WARNINGS AND PRECAUTIONS



This appliance must be installed, commissioned and serviced by a qualified person in accordance with national and local regulations in force in the country of installation.

If the supply cord is damaged, it must be replaced by the manufacturer, its service agent or similarly qualified person.

Ensure that the plug/socket is accessible at all times.

Strip plastic coating and clean the appliance before use.

During operation parts may become hot - avoid accidental contact.

Disconnect this appliance before servicing, maintenance or cleaning.



The thermostats within this unit contain Potassium-Sodium alloy that react with water and can cause burns. Under no circumstances should the capillary/bulb be cut open.

INSTALLATION AND COMMISSIONING

This appliance must be earthed.



An equipotential bonding terminal is provided to allow cross bonding with other equipment.

Install this appliance on a level surface ensuring all vents are unobstructed. Do not site on wooden or Formica surfaces. Keep a gap of 25mm below the base and the surface on which it is situated. See Fig 1 for minimum distances . A 100mm B 1000mm.



If replacing the plug connect the terminals as follows:

Green and Yellow wire Earth E
Blue wire Neutral N
Brown wire Live L

Means of isolation with at least 3mm contact separation in all poles must be incorporated into the fixed wiring of this appliance.

The fixed wiring insulation must be protected by insulated sleeving having a temperature rating of 60 Deg C.

Supply cords shall be oil resistant, sheathed flexible cable not lighter than ordinary polychloroprene or equivalent elastomer sheathed cord (code 60245 IEC 57)

The PO425 is fitted with a 13 amp plug. All other units are fitted with a terminal connection labelled as follows:

1	Live 1	Brown
2	Live 2	Black
3	Live 3	Grey
Ν	Neutral	Blue
Ν	Neutral	Blue (connect to the other N terminal with the supplied link)
Ε	Earth	Green/Yellow

OPERATING INSTRUCTIONS

Only qualified or trained personnel should use this appliance.

Refer to Fig 2 for control functions.



Turn the top element control knob (B) to the desired setting. The amber neon (A) will illuminate.

Turn the bottom element control knob (E) to 3 to pre-heat the appliance. The amber neon (F) will illuminate.

The top control knob controls a thermostat, and the amber neon (A) will go off when the oven has reached the desired temperature. The lower control knob controls an energy regulator . the setting of 3 is a recommendation - adjust to suit individual requirements. The lower amber neon (F) will cycle on and off as the energy regulator controls the power to the bottom element. The energy regulator should not be left on maximum.

The oven temperature is indicated by the dial (D). There is an audible timer (G).

Safety Thermostat

All models are fitted with a safety thermostat to protect the appliance in the event of control thermostat failure. Twin models are fitted with two safety thermostat, one per oven.

If necessary, re-set the safety thermostat by pressing the red button (A) in Fig 3. The re-set cannot be activated until the oven has cooled.



CLEANING



Do not use a water jet or steam cleaner, and do not immerse this appliance.

Clean all panels with warm water and mild detergent, do not use abrasive materials. Dry with a soft cloth.

Occasionally remove the kiln bats and sweep out any debris from the base of the appliance.
